SPEAKER'S PROFILE

Brad Wenstrup

A Cincinnati native, Congressman Wenstrup was elected in 2012 to represent the people of Ohio's Second Congressional District in the U.S. House of Representatives. He brings with him experiences as a doctor, Army Reserve officer, Iraq War veteran, and small business owner to help Congress tackle the challenges facing Ohio and the nation.

In the 114th Congress, Congressman Wenstrup serves on the following Committees: House Armed Services, the House Permanent Select Committee on Intelligence, and Veterans' Affairs. He is working to strengthen our military and national defense, help our returning service members' transition into civilian life, and support southern Ohio's veteran community.

Mike DeWine

Attorney General DeWine has served as an Ohio State Senator, as a Member of the U.S. House of Representatives, as Ohio Lieutenant Governor, and as a U.S. Senator. In each of the offices he has held, he has focused particular attention on efforts to protect children; ranging from making sure the prescriptions children take are safe and effective to helping foster children get into permanent, stable, loving homes. Mr. DeWine wrote Ohio's first truly tough drunk driving law and has been a leading proponent for highway safety. Additionally, Mr. DeWine has been a staunch advocate for victims of crime.—

SPEAKER'S PROFILE

Dennis Deters

Dennis Deters currently serves as the Vice President of the Hamilton County Board of Commissioners. Commissioner Deters was appointed to the Board in January 2016 after serving six years as Trustee in Colerain Township, one of the largest townships in the state of Ohio.

In 2015, Colerain Township instituted the County's first "Quick Response Team" to address the heroin epidemic. Through a partnership of law enforcement and treatment providers, overdoses in Colerain Township have been reduced by one-third.

Commissioner Deters currently serves as the Chair of the Hamilton County Heroin Coalition as well as a member of the Storm Water District Oversight Board, the Downtown Cincinnati, Inc. Executive Committee and the REDI Cincinnati Executive Committee. Commissioner Deters also volunteers his time with Operation Legal Help Ohio to provide free legal assistance to veterans.

Tom Fallon

Lieutenant Tom Fallon of the Norwood Police Department has served for 26 years, the last 17 on various task forces including the Criminal Investigative Section, the Norwood Drug Unit, and currently serves as the Hamilton County Heroin Task Force Director.
