# 2015 IFC High - Piled Combustible Storage

The 2015 IFC High-piled Combustible Storage seminar provides a basic understanding of the hazards associated with high-piled combustible storage and introduces the participants to the provisions in Chapter 32 of the 2015 edition of the International Fire Code (IFC). This seminar places special emphasis on the classification of commodities and understanding the design criteria in NFPA 13 for storage. Course objectives include: Apply the requirements of Chapter 32 for high-piled combustible storage; Identify the various storage methods for high-piled combustible storage; Describe how each storage method contributes to fire behavior; Explain the basic requirements of NFPA 13, Standard for the Installation of Sprinkler Systems, 2010 edition, for storage occupancies; Describe the scope and application of Chapter 32 of the IFC; Explain the commodity classification system based on the criteria in Section 3203 of the IFC.

#### Arco Recycling Fire East Cleveland, Ohio

Over a five-day period in October 2017, the East Cleveland Fire Department, with the help of numerous mutual aid agencies conducted fire suppression operations at Arco Recycling. Construction and demolition debris had been dumped there and covered over 9 acres and was piled over five-stories high. Pockets within the pile had caught fire resulting in fire suppression efforts, in addition to involvement from County, State, and Federal resources. The workshop will cover lessons learned from several Northeast Chiefs who operated at the incident. An overview of the incident, including stakeholder concerns, will be offered along with key takeaways attendees can use if an EOC activation and expansion of the incident command system is required in their area.

# **Blast Stages and Injuries**

This presentation is on IED's related to some of the commercial and homemade explosives used today. Since fire/medic companies are normally one of the first to respond to explosions, we need to be familiar with the various typologies and associated injuries. We enter many structures on a daily basis and are subjected to many dangers. We are also in the unique position to assist Law Enforcement when we observe any bomb-making components. We cannot report on components which we do not know may be used in IED construction unless we foster that knowledge base. Firefighters and medics alike have been known to identify various components of bombs which have thwarted terrorist efforts. Responding to lives in danger is our forte; however, helping to prevent catastrophic events is also a duty of ours. Discussed will be the blast stages and the associated injuries. Treating these injuries can be complex and difficult. The treatment focus will be on explaining the Lethal Triad of Trauma and how to avoid this deadly trap.

# Cardiovascular & Chemical Exposure Risks in Modern Firefighting

The proposed class will provide an overview of recent research conducted at Underwriters Laboratories (UL) and the National Institute of Standards and Technology (NIST) as it pertains to fire behavior, ventilation and building construction. The Modern Fire Environment has changed from the environment encountered by the fire service just twenty years ago. The fuel package in today's residential occupancy has experienced a wide spread inclusion of synthetic products that produce a very different burning characteristic than natural materials. This fuel package has created a fire scenario that produces an increased heat release rate producing an increased risk to fire fighters. This fire environment has also created a more dramatic impact on the structural elements of today's structures. We will also examine the changes in today's construction practices and how today's fires will impact the structural integrity of the fire fighter's work environment. This presentation will also cover the recent tests conducted at the Illinois Fire Service Institute, who in collaboration with UL FSRI, NIOSH and Skidmore College, studied the cardiovascular impact of various firefighting assignments and the exposure to the carcinogenic elements. Dr. Kenny Fent, of NIOSH, will review exposure and contamination findings of the study. Dr. Fent will review the elements measured within the atmosphere, the fire fighter's PPE and the operating fire fighter. During the class we will cover the various aspects of fire behavior, building construction and the impact of ventilation on fire behavior. We will also bring it together and discuss how this new understanding of the modern fire environment impacts fire fighter operations. As situations develop in complicity it is important to remember the basics. The research is not indicating everything the fire service has done is wrong, in fact it is driving us back to our basics to our foundation. To operate effectively and safely on the fireground, fire fighters and fire officers must remember the basics, or ABC's, of fire fighter and they are the Three C's, Communication, Coordination and Control. If we can follow these basic tenants we can improve fire fighter safety on the fireground.

#### **Ohio Assist Program**

Critical and traumatic incidents can have varied and long-reaching impacts on a public safety agency, at all levels. Some could be dealing with the incident itself, injury or worse to a friend and or co-worker but chief executives have additional issues, not shared by others within the department. In addition to the effects felt by other members of the agency, chief executives often have the added responsibilities of the media, staffing coverage, and benefits for the employee or their family, addressing operational and administrative questions regarding the incident, response to the incident and any subsequent fallout. Chief executives also have to address questions and concerns from governmental agencies tasked with overseeing public safety in their jurisdiction. Sometimes these folks may be unknowledgeable about the work we do, the dangers we face and the toll it takes on our personnel. Many command level officers feel they must maintain a visual image for their agency as a whole and not allow themselves the chance to acknowledge their own reactions to these incidents. Given the paramilitary culture of public safety. sergeants don't ask chiefs if they are OK. Just not something we have done in the past. These incidents could include; the death or serious injury of any member of the agency, (either on or off duty), serious illness, use of deadly force by or against an officer, mass casualty, death involving children or older folks, or anything that overwhelms their personnel's ability to cope. After the Call was created to provide chief executives with some ideas, concepts and techniques they might use to help themselves during a critical or traumatic incident. We also want to let these officers know that, just like the rest of their agency, they are having a normal reaction to an abnormal circumstance. It's not only ok to ask for assistance, it will help ensure that they are able to provide the guidance and oversight to help their agency and it's personnel work through the aftermath to be stronger than before the incident happened.

# Single Engine Residential Fires (SERF): The Critical First 10 Minutes

The first 10 minutes on the fireground is what determines the eventual outcome. How you perform during The Critical 10 minutes is directly related to prior training and preparation. This training usually focuses independently on hose selection, search, forcible entry, ground ladders and ventilation. Incident Command training rarely leaves the training room. We often neglect to actually combine all of those pieces together, and very rarely do these global training sessions occur during realistic live-fire training. This class has been very successful at BGSU Fall Fire School for the past 7 years with very positive student feedback. This classroom session will introduce you to the SERF program and challenge you to take a good look at how you operate on the fireground. It will cover fire behavior, how to apply UL/NIST information to the street, leadership on the fireground, company level training, size-up, radio traffic, overhaul, and will review live-fire evolutions conducted in past SERF classes.

#### **Tactical EMS**

Some departments have SWAT medics but others do not. Tactical medicine is growing due to the number of shootings which have occurred frequently in the U.S. Police entry teams (Contact Teams) have and are being developed as I write this email to neutralize the shooter. Rescue Task Force (RTF) teams are also used where two medics enter a warm zone to treat & triage the wounded with a few PD officers used as security. This presentation will give a history of TEMS and discuss the preventable injuries associated with the tactical setting. Also discussed is how a SWAT run is activated, implemented, briefed, operated, concluded, and debriefed. We will focus largely on the role of the medic, not solely in regard to trauma, but also related to the medical aspect of keeping the operators

functioning in austere environments. A Medical Threat Assessment (MTA) must be formulated by researching, analyzing, and implementing a medical plan. The best medicine in the tactical setting is great preparation but great medicine at the wrong time can equal terrible tactics and a failed mission. Our mission in Akron is to catch the bad guy and go home to our families. Tactical medicine is a key component to the safety of all involved when a planned raid is enacted or when a Signal 100 occurs.

Alden, Jarred - Jarred Alden is a graduate of Kenton Ridge H.S. (1993); Urbana University (1997) B.A. degree; and Wright State University (2000) M.A. degree. His focus in college was psychology, sociology, law and applied behavioral sciences. He have worked for The Akron Fire Department for 14 1/2 years and 2 years of this time as a Lieutenant. Alden has also served as a diver for the water rescue team and he currently functions as a tactical medic for The Akron Police Department's SWAT team. Alden is currently stationed at station #14A in Goodyear Heights in Akron. Before joining AFD, Alden worked for Infocision Management Corporation as a Program Supervisor and the University of Akron as a sociology instructor. He instructed on topics such as research methods, basic statistics, culture, social structure/processes, social networks, socialization, deviance, crime, politics & economy, terrorism, education, gender, race and collective behaviors.



Carney, Brandy - Brandy Carney is the Director of Public Safety & Justice Services (PSJS) for Cuyahoga County, in Cleveland Ohio. PSJS is made up of seven divisions which include the County 911 Dispatch Center (CECOMS), Office of Emergency Management, Criminal Justice Information Services (CJIS), Grants and Fiscal, Witness Victim Service Center, Administration/ Project Management and the Northeast Ohio Regional Fusion Center (NEORFC). She manages the department's day-to-day operations, including a budget of over thirty-five (35) million dollars made up of grants, general fund and other revenue sources, and works closely with all divisions to make sure they are functioning at the highest level possible and supporting the mission of the County Executive and County Council. PSJS supports needs of public safety and criminal justice organizations throughout the County, providing a myriad of services including fiscal, grant administration, policy and project management, to over 60 law enforcement agencies and 52 fire departments within the 59 communities in Cuyahoga County.



Cassano, Sal – Salvatore J. Cassano served as the 32<sup>nd</sup> Fire Commissioner in the 151-year history of the New York City Fire Department (FDNY), leading the United States' largest fire department with more than 16,000 fire, EMS and civilian members, and an annual budget of \$1.6 billion. Commissioner Cassano spent over 44 years in the FDNY and held every uniformed rank prior to his appointment by Mayor Michael R. Bloomberg in January, 2010. Commissioner Cassano served as the FDNY's Chief of Department-the highest-ranking uniformed officer-from 2006 through 2010, overseeing many of the agency's most important bureaus including Fire and EMS Operations, Training, Safety, Fire Prevention and Communications. From 2001 to 2006, he served as Chief of Operations-a position to which he was appointed immediately after Sept. 11, 2001. Both as Chief of Operations and Chief of Department, Commissioner Cassano played a crucial role in rebuilding the Department in the wake of Sept. 11 and the loss of 343

members of the Department. In the years that followed, more than 6,800 new firefighters were hired and more than 6,000 others were promoted to various officer ranks as the Department went through a difficult but remarkable resurgence. Under his leadership, the FDNY became better equipped, trained and prepared than ever before in its history, and achieved unprecedented success with the fewest civilian fire fatalities ever and the fastest response times on record. Commissioner Cassano's career with the FDNY began with his appointment as a firefighter on Nov. 29, 1969. He steadily rose through the ranks with promotions to lieutenant (August 1977), captain (April 1984), battalion chief (August 1987), deputy chief (June 1993), deputy assistant chief (November 1999) and assistant chief (April 2001). Five times during his career he was cited for bravery. Prior to joining the FDNY, Commissioner Cassano served in the U.S. Army from October 1965 through July 1967 and was deployed to Vietnam in September 1966. While a firefighter, he attended John Jay College of Criminal Justice and received a Bachelor of Science degree in Fire Science. Commissioner Cassano also received an Honorary Doctor of Laws Degree from St. John's University in May, 2013. In September 2009, Commissioner Cassano was awarded France's highest decoration, the Legion D'Honneur by French President Nicolas Sarkozy. Commissioner Cassano grew up in Brooklyn and is a lifelong resident of New York City. He and his wife, Theresa, reside in Staten Island. They have five children and eight grandchildren.



Celiga, Mike - Chief Michael Celiga has been in the fire service since 1991, working for the Oakwood Village Fire Department until joining the East Cleveland Fire Department (ECFD), located in Cuyahoga County, in October 1997. In his over twenty years with ECFD, he has served in many executive ranks including Lieutenant, Captain and Deputy Chief. ECFD is a busy suburban department running over 6,000 emergency service calls annually for Fire and EMS response. Chief Celiga as responded to over 800 structure fires in his career at ECFD. In 2003 he received and currently maintains his paramedic certification. Chief Celiga continues to attain various other fire, emergency response and command education to support his career work. He leads a department of 42 professional full-time firefighters, and 18 part-time, manning two engines, a truck company, two rescue squads and a command vehicle operating out of two stations. In addition to his leadership with the ECFD, he currently works fire and EMS response for Concord Fire Department in Lake County.



**Cerda, Gunnar** – Rev. Gunnar Cerda is Ordained in the United Church of Christ and a Board Certified Chaplain. He is the Manager of Pastoral Care for OhioHealth Grant Medical Center, Freestanding Emergency Departments and Ambulatory Services and has been with OhioHealth for 10 years. Gunnar lives in Delaware, Ohio with his wife, two kids and two dogs.



Click, Steven - Lieutenant Steven M. Click is assigned to the Ohio State Highway Patrol, Office of Personnel / Ohio ASSIST program. Lieutenant Click has been involved in peer support with the Patrol's Member's Assistance Team (MAT) since its inception in 2002. He previously served as the Operational Commander. He now helps oversee all aspects of the MAT including policies, activations and training. Lieutenant Click has been active in peer support since being CISM trained in 1993. He was deployed to New York City twice after the 9/11 attacks and worked with the NYPD peer support program, POPPA. Lieutenant Click is trained in both group and individual peer support by the International Critical Incident Stress Foundation. As a part of his current duties, he oversees the Post Critical Incident Seminars for Ohio. He has been utilized as a peer in South Carolina, Texas and Georgia, for their PCIS / STLS programs. He serves as the Crisis Awareness Training instructor for ASSIST, having provided this training to a number of Ohio agencies including the Highway Patrol. **DeCrane, Sean** - Sean DeCrane is a 25+ year veteran of the Cleveland Division of Fire. He has risen through the ranks and currently serves as a Battalion Chief covering Cleveland's Westside. He has served as the Director of Training and Acting Chief of Operations. Sean has been very involved in the research at Underwriters Laboratories and the National Institute of Standards and Technology. He serves on the UL Fire Council, is a member of the UL Fire Fighter Safety Research Institute's Advisory Board and is currently on a number of technical panels for research and standards. Chief DeCrane also represents the International Association of Fire Fighters in the International Code Council process and has served on the 2009, 2012, 2105 and 2018 Fire Code Developing Committee and as Chair for 2015 and 2018. Sean serves on the NFPA 1 Technical Advisory Panel, NFPA Research Foundation on Tall Wood Buildings and was recently appointed as the IAFF alternate to the NFPA Fire Behavior Research Technical Committee. Sean was recently awarded the 2015 UL Council Member's Achievement Award, 2014 Fire Equipment Manufacturer's Fire Safety Advocate of the Year Award, the 2013 International Association of Fire Chiefs Life Safety Award and the 2012 ICC-IAFC Life Safety Advocate Award. Sean recently was the keynote speaker for the 2015 Fire Department Instructor's Conference.



**Dixon, Charlie** - Charlie Dixon, Safety and Workforce Director for the Ohio Oil and Gas Energy Education Program (OOGEEP) and has been actively involved in Ohio's Fire Service since 1977. Charlie has served as a fulltime Captain / Paramedic Granville Volunteer Fire Department Inc. (Retired), EMS Instructor for the City of Columbus Division of Fire, Fire Training Supervisor with the Ohio Fire Academy, Fire / EMT Instructor for C-TEC of Licking County, Bladensburg, OH, V.F.D. Charlie is currently the Secretary / Treasurer for the Ohio Society of Fire Instructors (OSFSI), Represents the Flammable Liquids Industry on State Fire Council, Certified Fire Instructor, International Association of Drilling Contractors (IADC) RigPass SafeLand Instructor, member of International Society of Fire Service Instructors (ISFSI). The New Concord Fire Department is a combination department responding to over 1,400 calls per year. Chief Gates is active in the State of Ohio with the Ohio Fire Chiefs' Association, President of Southeast Ohio Fire Chiefs, as an instructor at the Ohio Fire Academy, active as a lead fire instructor with the Ohio Oil and Gas Energy Education Program (OOGEEP) Responding to Oilfield Emergencies Academy, a member of the International Association of Fire Chiefs (IAFC), the International Society of Fire Service Instructors (ISFSI), and the Ohio Society of Fire Service Instructors (OSFSI).



Horn, Gavin - Gavin Horn has served as the IFSI Director of Research since 2004, immediately after receiving his PhD in Mechanical Engineering from the University of Illinois at Urbana-Champaign. Tim is a strong advocate for firefighter health and wellness and frequently competes in long distance triathlons and related fitness events around the world.
